COMMUNITY OUTREACH February Donations Aid Evangel Home

The charity for our February luncheon will be the Evangel Home. Founded in 1955, Evangel Home was among the first facilities in the nation dedicated to supporting women. They are proud of their history and grateful for those early pioneers whose vision, courage, and compassion laid the foundation for who they are today.

"Once upon a time, we chose the prickly little hedgehog as our mascot. Several traits of the hedgehog then, and now, remind us of who we strive to be at Evangel Home. Hedgehogs don't seek out problems, but when faced with one, they pause. At Evangel Home, we do the same. Instead of reacting hastily, we stop, assess, and seek God's guidance, proceeding only when ready. It's encouraging to see how this approach has brought positive change and a renewed sense of God's presence in our work."

Some of their programs are:

- Crisis Shelter 30 day emergency shelter. Houses up to 24 women and children, Includes meals, shelter, clothing, chapel, and counseling.
- Nine-month residential program Teaches basic living skills and discipleship; includes parenting skills, boundary setting, finances, Bible study, and counseling; provides childcare for mothers who need it. Built for mothers with children - if you're a mother with children, they will also have a safe place to stay at Evangel Home. Together, both mother and children will find food, shelter, and hope for today and the future. While mom is busy building a better and brighter future, the children are safe and enjoying themselves today.
- Cross Roads graduates employed or attending school full-time: Classes and services include weekly aftercare sessions and on-site housing and support. Counseling is also offered.

Recommended REFCO Membership Fee Increase

Dear Fresno County Retirees,

We want to inform you about an important update regarding your membership with the Retired Employees of Fresno County (REFCO).

Proposed Membership Fee Increase: The REFCO Board is recommending a \$1 increase per month in your membership fee. This means with the additional dollar the total monthly membership fee would be \$2 a month or \$24 annually.

Why the Increase? Our commitment to you remains our top priority. The proposed fee adjustment will allow us to:

- Enhance our scholarship program for our retirees' family members.
- Organize more engaging and enriching events.
- Develop and implement newer technologies to provide our membership (you) with easy-to-use tools to stay informed on all REFCO activities and other issues that impact our retirement.

Next Steps: This recommendation will be discussed and voted on at the upcoming annual REFCO Board Meeting held at the February luncheon. We encourage all members to attend and share their thoughts. Your feedback is crucial to our decision-making process.



*This certificate is a two-year term. The rate may be increased once during the term up to 1.00% Annual Percentage Yield. The new rate will then be in effect for the remainder of the term. An additional deposit can be made once during the term and cannot exceed the original CD deposit; total balance cannot exceed \$500,000. The one-time withdrawal can be up to a maximum of 25% of the original CD balance. Amounts withdrawn in excess of the limit are subject to standard early withdrawal penalties. Certificate balance may not drop below \$2,500 per withdrawal. Federally Insured by NCUA.
