### Open Enrollment: Plan Year 2022

Open Enrollment for Plan Year 2022 is scheduled to begin on **Monday**, **October 11**, **2021** and will continue through **Friday**, **November 5**, **2021**. Open Enrollment is the one time during the year that you may enroll in one of the County's health insurance plans or make changes to the plans you are currently enrolled in without a qualifying event. If you choose to enroll or make any changes, coverage will take effect **January 1**, **2022**.

#### What Changes Are there For Plan Year 2022?

For the 2022 plan year, the County of Fresno will continue to offer Anthem Blue Cross HDPPO, United American supplemental, and Kaiser Senior Advantage High and Low Options. If you do not want to enroll or make any changes to the plans you are currently enrolled in, <u>no action is required on your part</u>. The new rates for plan year 2022 can be found on the next page. <u>Please note – these rates were approved by the County of Fresno Board on September 21, 2021</u>.

Step Child	Certified Birth Certificate/ Abstract and a Certified Marriage Certificate/ Abstract/Declaration of Domestic Partnership showing your spouse/registered domestic partner as the child's parent
Child of Legal Guardianship	Letters of Guardianship filed with the courts

Please note: The required documents listed above must be submitted each time a dependent is added to your health insurance, regardless if the dependent has been covered under your plan previously.

#### Can I Make Changes to My Health Insurance Plan Once Open Enrollment Closes?

Once Open Enrollment closes, you will not be permitted to enroll or make changes until the next Open Enrollment period, unless you experience
